#### 2. PURPOSE:

# 7.2.2. Cookie Policy:

A cookie is a small file that asks permission to be placed on your electronic device which support browsing. Once you agree, the file is added, and the cookie helps analyze web traffic or lets you know when you visit a particular site. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes, and dislikes by gathering and remembering information about your preferences.

We may use traffic log cookies to identify which pages are being used. This helps us analyse data about web page traffic and improve our website in order to tailor it to customer needs. We only use this information for statistical analysis purposes, and then the data is removed or anonymize it from the system.

Overall, cookies help us provide you with a better website by enabling us to monitor which pages you find useful and which you do not. A cookie in no way gives us access to your computer or any information about you other than the data you choose to share with us.

Whenever a user visits Arcolab's website, the IP Address is identified and logged automatically in Arcolab's server along with the time of the visit and the pages that were visited. IP Addresses are used for helping diagnose server problems and administering the website.
